4. MEMBERSHIP :

1. Individual membership will upon to persons of both sex above the age of eighteen and be residing in Thanjavur District. Monthly subscription Rs.3/-
2. They must be interested in the promotion of the society aims.
3. Members shall be co-opted by the Executive Committee.
4. A member shall forfeit his membership if he is found and proved to be a criminal and his being in the Association would mar the smooth running of the Association. This decision should be passed by a majority of the Executive Committee.
5. Members are eligible to get copies of by laws, the Receipt and Expenditure Accounts and the Balance Sheet on Application and necessary fees of Rs.1/- for each copy of document required.
6. The copy of the register of members will be filed with the Registrar within one month from the date of registration of the society.

5. EXECUTIVE COMMITTEE :

There shall be an executive committee of the Association consisting of a President, a Secretary, and Treasurer, Vice-President, one Joint Secretary, and ~~two~~ <sup>two</sup> members. The Executive Committee shall be given power to co-opt members from time to time. It shall have the power to appoint sub-committees from time to time.

The President, Secretary, Treasurer and Vice President Joint Secretary, two Executive Committee members shall be elected from among the ordinary members of the Institution in a General Body Meeting to be held once in three years within six months after the expiry financial year. Any vacancy in the Executive Committee in the middle shall be filled up by the Executive Committee by way of co-option



6. THE PRESIDENT:

9. JOINT SECRETARY :



11. EXECUTIVE COMMITTEE MEMBERS:

- a. The executive committee will ordinarily meet once in three months to be convened by the Secretary
- b. Seven days notice shall be given for the meeting of the Executive Committee
- c. The president and the Secretary may however decide to convene a meeting at short notice according to exigencies and circumstances
- d. Four member shall form the quorum of the Executive Committee
- e. Executive Committee is empowered to appoint an Accountant for arrangement of day to day administration of the Association. It will decide the quantum of amount to be paid to him monthly and the service conditions of the employees

12. GENERAL BODY MEETING:

- a. There shall be an annual general body meeting when the yearly report and the yearly audited statements of the accounts will be presented. The annual General Body Meeting will be held once in a year within six months after the expiry of financial year
- b. There shall be a General Body Meeting of the Association. Once in three years within six months after the expiry of financial year for the election of office bearers, members of the Executive Committee and appointment of Auditor
- c. The President shall be also call an extra-ordinary General Body Meeting on the requisition given by atleast 1/5th of the members on the rolls of the Association stating the specific purpose of the meeting. At such a meeting only the said specific purpose to transact unless otherwise decided by the president at the meeting
- d. Twenty one days prior notice, specifying therein the day, the hour, place and the object of the meeting in case any amendment of a bye-law or objects of the Association in the memorandum is intended to be proposed shall contain a copy of every such amendment
- e. The president may, however, decide on a shorter notice according to exigencies of circumstances
- f. 3/4 of the members on the rolls of the Association shall form a quorum for a general body meeting
- g. Any members desirous of moving any proposition at the general body meeting shall give notice in writing of the same to the Secretary not less than eight days before the date of meeting. Only such propositions as of them are approved by the president, shall be placed before the General Body Meeting
- h. The president shall allow all members on requisition in writing to inspect the records in the office during office hours, free of charge.
- i. The president shall file the following records referred in Sec. 16 of the Tamil Nadu Societies Registration Act 1975 before the Registrar on or before 15th July every year

1. An authenticates copy of such receipts and expenditures account, balance sheet and report
2. As statement of the name and addressee and occupation of the persons, who at the expiry of the financial year, were members of the registered society and list of Executive Committee Members
3. A declaration to the effect that the Association had been carrying on business or has been in operation during the financial year
4. The above documents shall be placed before the General Body within 3 months after the expiration of the financial year to which the account relates and the copy of these records should be filed with the Registrar within one month from the state of the general body meeting

13. FUNDS :

- a. In order to carry out the objectives of the Association the executive committee shall have power to raise funds through donations, fees, contribution and aid from Governmental and as well non-Governmental agencies and such other means as Executive Committee may decide from time to time. The funds of Association which is not immediately required may be invested or deposited in the following manner  
upon immovable properties, (ii) special account opened in a bank as defined in Banking Regulation Act 1949 (iii) in units issued by Unit Trust of India (iv) in securities of undertaking of Government of Tamil Nadu or Government of India (v) in post office savings Bank account (vi) in a Society registered or deemed to be registered under the Tamil Nadu Co-operative Societies 1961
- b. The executive Committee shall also have the power to mortgage the property and other assets of the Association for the purpose of raising loans/grants
- c. No part of the end of the Association shall be divided by way of bonus or dividends or otherwise among its members. No fund is ear marked to a deponent of a deceased or disabled member of the Association
- d. The annual income of the Association is estimated to be Rs.10,000/- (Rupees Ten thousand only)

14. EXECUTION OF DOCUMENTS :

All documents regarding loans or other transactions involving creation of encumbrances on the movable and immovable property of the Association shall be executed jointly by the president and secretary of the Association

15. RAISING OF LOANS :

- a. A decision to raise a loan shall be passed at a special meeting of the Executive Committee convened for the purpose of majority of not less than 3/4 of the members present and not less than the half of the total members of the Executive Committee

- b. Copies of such decision shall be posted to every member of the Executive Committee
  - c. Any member of the Executive Committee shall have the right to object to the raising of the loan or to suggest any amendments of the said decision within 21 days of the days of posting of the information in the event of non-objection being received it will be presumed that the members agree to the proposal
  - d. If no objection is received from any member within the time prescribed, the committee shall have the power to raise the loan on the terms and conditions proposed and to take such further action as may be necessary. 16. ACCOUNTS :

- a. An account of the Association shall be opened in a Bank to be decided upon by the Executive Committee. The Secretary and the Treasurer shall jointly operate the account.
- b. They shall together to the custodians of all its funds
- c. Accounts mentioned in Rule 18 of the Tamil Nadu Society Registration Rule 1978 shall be maintained by the Committee

17. RULES :

The rules for the conduct of the Association may be framed by the Executive Committee and intimated to all the members of the Association for information

18. ADMINISTRATION:

- a. Change in the Memorandum and the constitution of the Association may be suggested in writing by any member to the President and Secretary to be placed before the Executive Committee
- b. The decision to make a change will be passed by 3/4 majority of the total number of members
- c. The accounts of the Association shall be audited by a Chartered Accountant to be appointed by the Committee
- d. If any member of the Association or the Officer appointed under clause G of Section II of the Act found to have been breached the provisions of the bye-law of the Association the Executive Committee is empowered to find them to the extent of Rs.50/- and the man penalised is at liberty to appeal to the General Body for any decision in this regard
- e. The Register of members the books containing minutes and the books of accounts will be exhibited at the Registered Office of the Association during the business hours for inspection by its members free of charge

19. DISSOLUTION:

The president shall be <sup>call in</sup> extra-ordinary General Body Meeting on the requisition given by atleast 2/3 of the members on the rolls of the association stating that they desire a consideration of the question of the dissolution of the Association. A decision to dissolve the Association shall be passed by a majority of not less than 3/4 of the members of the total number of members on the rolls of the Association. In the event of such a decision being taken the executing Committee shall take all necessary steps for the winding up of dissolution of the Association. The Executing Committee shall cease to function only after the winding up dissolution is completed.

20. The signatories in the Memorandum of the Association of which this constitution forms the annexure shall hold office as the first executive committee of the Association with the responsibility of that indicated against each for a period of three years from the date on which they have signed this memorandum of the Association.

21. If, upon the dissolution of this Association there shall remain after the satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the members of the said Association of any of them but shall be given to some other Registered Society having the same objects to be decided upon the 3/4 majority of members at the time of dissolution.

22. For all things not specifically provided for in the Institution the provision of Tamil Nadu Societies Registration Act, 27 of 1975 will apply.
